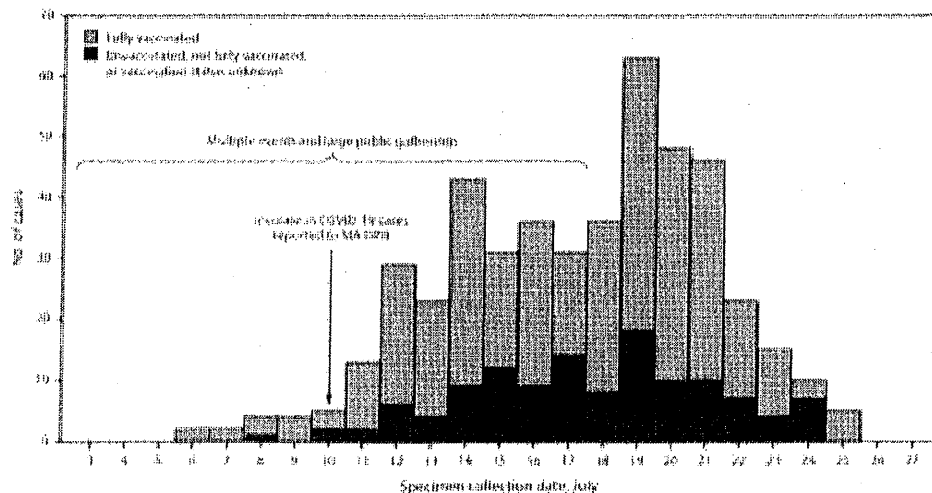

This latter element requires that before the acceptance of an affirmative decision by the experimental subject there should be made known to him the nature, duration, and purpose of the experiment; the method and means by which it is to be conducted; all inconveniences and hazards reasonably to be expected; and the effects upon his health or person which may possibly come from his participation in the experiment.

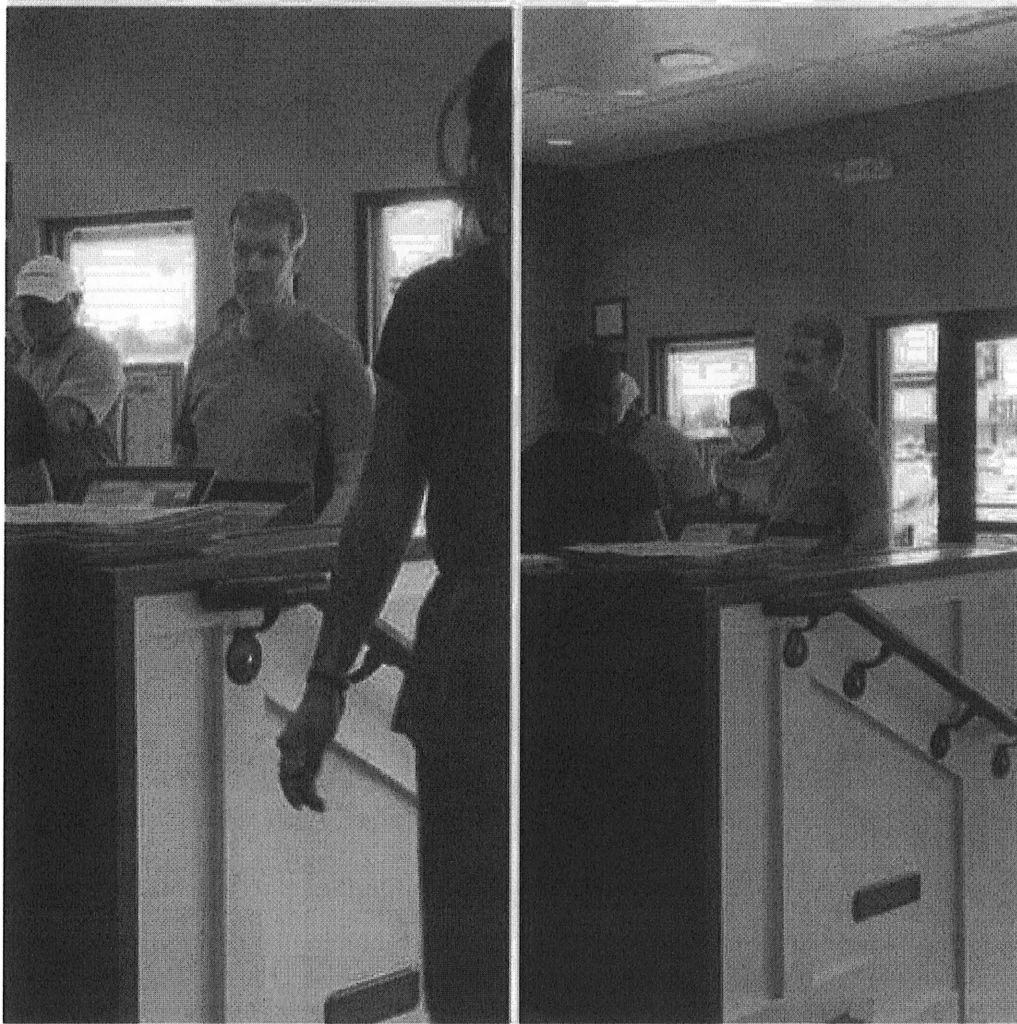
Stop directing the safety of families in this county. You do NOT know what is best. We have the right to direct our own health care as well as that of our children. #Noncompliant

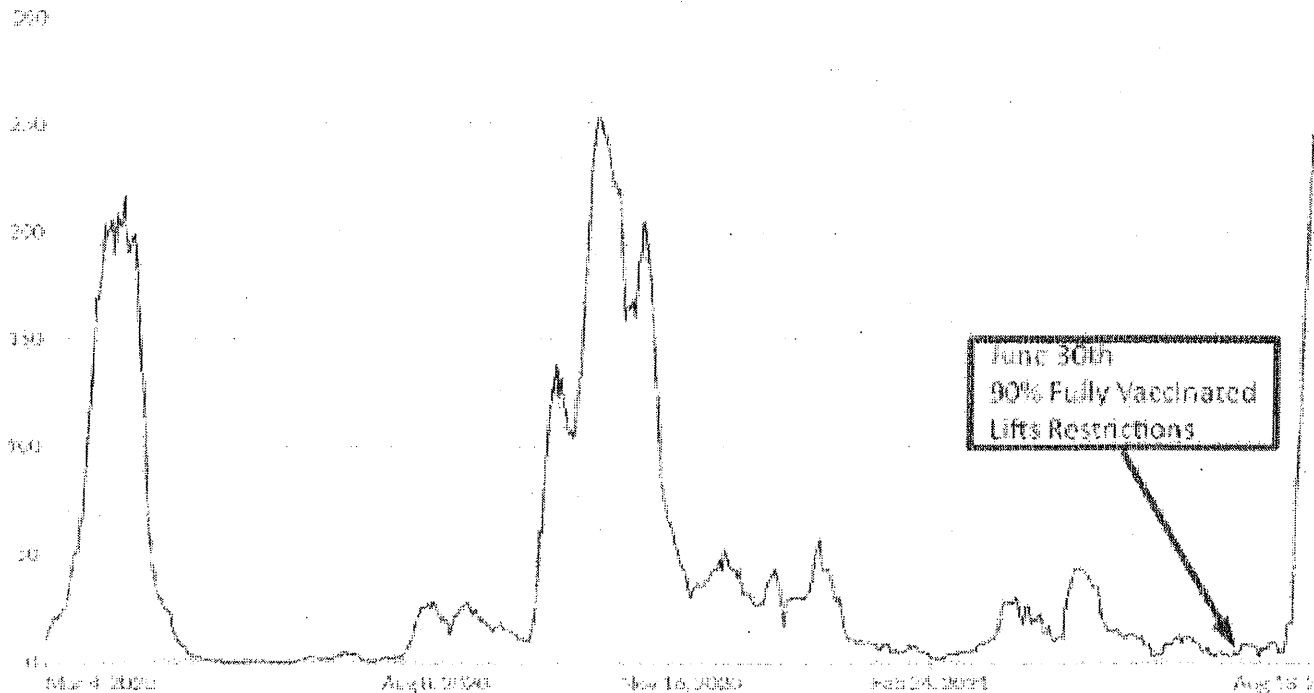

Dear Pima County Board of Supervisors,

This letter is being sent in hopes of dissuading you from mandating vaccines in our county.

First off, forcing the entire health care community to receive an injection, which many may not need or want, is a very un-American thing to do. You may say, "what do you mean, 'not need', everyone needs protection from this virus!" The truth is that evidence keeps coming in, although some individuals in our government don't want to acknowledge it, that people who have already had COVID have very comprehensive and long-lasting immunity; and, a whole lot of people in this country have already fought and won against this virus! That's a lot of people who already have strong natural immunity!

In fact, please remember that over 99% of people who get this virus WILL survive. Please read this during the Call to Audience at the August 16th Board of Supervisors meeting:

I urge you not to play God with people's health, lives, and livelihoods. Vote no on a vaccine mandate for all healthcare workers in Pima County.

First off, the premise for the emergency use authorization of the so-called Covid vaccine is flawed because experimental use authorization should only happen if there are no therapeutics that work.
