Subject: STOP Vaccine Mandates

We know that as the virus spreads that the genetic material can change, meaning that viruses can mutate into different variants. In a scenario with mass vaccination, a mechanism called antibody dependent enhancement (ADE) can occur. This means that instead of stopping an infection, antibodies can actually become more infectious.

A journal article published last week, In the Journal of Infection ("Infection-enhancing anti-SARS-CoV-2 antibodies recognize both the original Wuhan/D614G strain and Delta variants. A potential risk for mass vaccination") highlighting a startling scenario that could be associated with the rise in Covid cases during our current vaccine campaign. The study addresses is something called antibody dependent enhancement, referred to as ADE. This has been a potential concern for scientist since the very beginning of the vaccine campaign. In simple terms, there are antibodies that can neutralize the virus and there are antibodies that can facilitate the virus and allow it to become more infectious. In this study they state that "neutralizing antibodies have a **decreased** affinity for the spike proteins, whereas facilitating antibodies display a **strikingly increased** affinity."

"The epitope recognized by this antibody on the flat N- terminal domain surface is dramatically affected in the N terminal domain of Delta variant, suggesting a significant loss of activity in vaccinated people exposed to Delta variant. More generally, it can be reasonably assumed that the balance between neutralizing and facilitating antibodies may greatly differ according to the virus strain." and "The emergence of SARS- CoV-2 variants may tip the scales in favor of infection enhancement." They go on to say, "ADE may occur in people receiving vaccines based on the original Wuhan strain spike sequence (either mRNA or viral vectors) and then exposed to a Delta variant. Although this potential risk has been clearly anticipated before the massive use of COVID-19 vaccines, the ability of SARS-CoV-2 antibodies to mediate infection enhancement in vivo has never been formally demonstrated." and "...To the best of our knowledge ADE of Delta variants has not been specifically addressed." They go on to say "...since our data indicate that Delta variants are especially well recognized by infection enhancing antibodies targeting the N terminal domain, the possibility of a ADE should be further investigated as it may represent a potential risk for mass vaccination during the current Delta variant pandemic."

To recap this analysis, the neutralizing antibodies perform well against the original Wuhan virus, but in the case of the delta variant, the **neutralizing** antibodies of the vaccinated person have **diminished substantially** while the **facilitating antibodies** display a **strikingly increased affinity** for the spike protein, thus allowing infection to resume without proper immune notification.

One possible explanation that ADE has been repeatedly dismissed by some groups of scientists, while others have warned from the commencement of the vaccine campaign, the primary reason that an opponent of ADA would dismiss this is based on a short sided belief that ADE would easily be spotted in clinical trials by making the person sicker. What they fail to realize is that just because a person is not sicker, does not mean that they can't get infected easier. This is likely what is being seen right now, the virus is less virulent and less deadly but it's more infectious and transmissible.

A groundbreaking preprint paper by the prestigious Oxford University Clinical Research Group, published Aug 10 in the Lancet ("Transmission of SARS-CoV-2 Delta variant among vaccinated healthcare workers, Vietnam"), includes alarming findings that support the ADE hypothesis. The study found vaccinated individuals carry 251 times the viral load of COVID-19 virus in their nostril compared to the unvaccinated. While moderating the symptoms, the vaccine allows the vaccinated individuals to carry unusually high viral loads without becoming ill at first, potentially transforming the vaccinated individual into a pre-symptomatic super spreader.

"Findings: Between 11th–25th June 2021 (week 7–8 after dose 2), 69 healthcare workers were tested positive for SARS-CoV-2. 62 participated in the clinical study. 49 were (pre)symptomatic with one requiring oxygen supplementation. All recovered uneventfully. complete-genome sequences were obtained. They all belonged to the Delta variant, and were phylogenetically distinct from the contemporary Delta variant sequences obtained from community transmission cases, suggestive of ongoing transmission between the workers. Viral loads of breakthrough Delta variant infection cases were 251 times higher than those of cases infected with old strains detected between March–April 2020. Time from diagnosis to PCR negative was 8–33 days (median: 21). Neutralizing antibody levels after vaccination and at diagnosis of the cases were lower than those in the matched uninfected controls. There was no correlation between vaccine-induced neutralizing antibody levels and viral loads or the development of symptoms.

Interpretation: Breakthrough Delta variant infections are associated with high viral loads, prolonged PCR positivity, and low levels of vaccine-induced neutralizing antibodies, explaining the transmission between the vaccinated people. Physical distancing measures remain critical to reduce SARS-CoV-2 Delta variant transmission."

The scientists studied healthcare workers who were unable to leave the hospital for two weeks. The data showed that fully vaccinated workers — about two months after injection with the Oxford/AstraZeneca COVID-19 vaccine (AZD1222) — acquired, carried and presumably transmitted the Delta variant to their vaccinated colleagues.

They almost certainly also passed the Delta infection to **susceptible unvaccinated people, including their patients**. Sequencing of strains confirmed the workers transmitted SARS-CoV-2 to one another.

This is consistent with the observations in the U.S. from Farinholt and colleagues, and congruent with comments by the director of the Centers for Disease Control and Prevention conceding COVID-19 vaccines have failed to stop transmission of SARS-CoV-2.

On Feb. 11, the World Health Organization indicated the AZD1222 vaccine efficacy of 63.09% against the development of symptomatic SARS-CoV-2 infection. The conclusions of the Chau paper support the warnings by leading medical experts that the partial, non-sterilizing immunity from the three notoriously "leaky" COVID-19 vaccines allow carriage of 251 times the viral load of SARS-CoV-2 as compared to samples from the pre-vaccination era in 2020.

Vaccinated individuals are carrying concentrated viral loads into their communities and fueling new COVID surges. Vaccinated healthcare workers are almost certainly infecting their coworkers and patients, causing horrendous collateral damage.

Continued vaccination will only make this problem worse, particularly among frontline doctors and nurses workers who are caring for vulnerable patients.

Health systems should drop vaccine mandates immediately, take stock of COVID-19 recovered workers who are robustly immune to Delta and consider the ramifications of their current vaccinated healthcare workers as potential threats to high risk patients and coworkers. I am a hospital worker, and I can say that half of my COVID patients are vaccinated. HALF! The odds are not in the favor of the vaccine. This is no way to stop a pandemic.

Reports from Israel, the most vaccinated country, indicate that the vaccine has not stopped infections as 50% of their new COVID infections are in the vaccinated population. The new efficacy rate is 42% down from the 90% that provided at release of this vaccine.

I ask you, why would you want to mandate an irreversible medical therapy that is clearly, unproven and at this stage, an utter failure? This is not going to be the answer.

Last year healthcare workers were recognized as heroes as we marched off to work day in and day out. We did not know what we were facing. We were scared but we did it any way. We signed up to take care of others. How are we being repaid for that work? Now, 1 year latter, we are being threatened with our jobs and our livelihood if we do not submit to an experimental, ineffective vaccine. Many of us have had COVID, we have natural immunity (which given the latest studies, is far more effective than the vaccine) but no one wants to give us credit for real immunity. Instead, we are expected to take the jab, which provides us no additional benefit and forces us to assume all of the risk (side effects), why? Eight to nine out of 10 covid infections are mild, do not lead to hospitalization or death. The delta variant may be more contagious, but is far less deadly. Those who are at the highest risk are those with co-morbidities (obesity, hypertension, diabetes), we would be far better off to develop a program to focus on actually getting people healthy. Emphasize the importance of vitamin D, healthy eating, exercise and stress management. The next highest risk fact is stress and fear over Covid. Perhaps the fear mongering should STOP! People need to be informed of the truth instead of what will give the news media the highest ratings. People need to know there are available, outpatient treatments.

People are not dying in the streets from this disease. Look at our homeless, the grocery store workers, the fire department and healthcare workers, if it were as deadly as initial claims we would all be dead.

I implore you, DO NOT MANDATE this vaccine.
