As a resident of Pima county I have grave concerns about several items on the agenda for the Sept 7th meeting. In an effort to not take up too much time I will provide brief statements to each subjects but will gladly have more in depth conversation with supporting documentation if any of you would like to meet up and talk/ with a constituent.

- 1) Mask / vaccine mandates for schools. I am opposed to this action. The data does not support masking our children, doing so is equivalent to child abuse and an over reach of govt into parental rights. Allowing parents to decide is the only right decision. Given the conflicting data on the safety AND protection longevity covid 19 vaccination sld be a personal choice until It has completed its full testing thru 2025 (and proven safe and effective as a result of that testing)

I have a son who currently serves so I am very sympathetic to the i interpreters and their families but that is NOT just those individuals that made it out of Afghanistan, I wont go into horrific situation or the fact of the chaos allowing so many unvetted individuals in this country BUT instead remind you we have a homeless problem in this county, we have vets that are on the street. We sld be focused on helping our own first and foremost. I am opposed to using any of our hard earned tax dollars to anyone before supporting our vets/ homeless.
- 4) mandating healthcare workers to vaccinate. Seriously, demanding those who worked unprotected over a year and 1/2 thru this pandemic to take a Vaccination against their will is beyond disgusting. The hypocrisy is astounding..
