Dear Board of Supervisors:

I am sending this request to you because I am afraid of what is happening to our Democracy.

I have lived for the first part of my life under the authoritarian regime in Romania. I know what that is. I have experienced what that feels like. I do not wish for the same to happen in the US.

With your vote, you have the power to contribute to preserving our Democracy, by supporting a democratic map that will ensure free and fair elections and our sacred right to vote.

I urge you to VOTE for **Option 1** because:

- Equal Representation should be at the heart of redistricting. Only **Option 1** meets this criterion.
- We oppose gerrymandering and Option 2 feels like that and makes Option 2 vulnerable to legal challenge.
 - Minority representation is protected by the Voting Rights Act which prohibits diluting minority

districts. **Option 1** has the best minority protection for all 3 minority districts.

- **Option 1**, without trying, is the best map for Constables, reducing JP 8's huge workload.

- **Option 1** creates a fair map that meets ALL the criteria of redistricting. This makes it "bullet-proof" for criticism or legal challenge.

Thus **Option 1** is the only option that conveys fairness to the public.

- We in Pima County expect fairness from our Judges in court.
