Agenda Item #9 Eviction Prevention Incentive

Landlords have the right to evict under Arizona State statute. The Board of Supervisors should not create methods to spend taxpayer's \$3Million based on Negative Economic Impact from Covid. Too many loopholes involving future payments to landlords who are already suffering from poor choices created by government overreach using Covid as the operative word. Landlords should proceed with the eviction process that will help move them toward locating tenants who will pay their bills. Why not use funds to help the evicted tenants find employment and pay the landlords proceeding with eviction a flat \$5,000 since they are the injured parties who also need to move forward. Addendum Item #4 Comprehensive Updates.

So why is the Administrator adding employees and approving overtime when the EARP programs are declining and processing time has almost been cut in half. Where is the logic? Vote No to this recommendation.

Addendum Item #6 Economic Development Office

Board of Supervisors always have the obligation to proceed with efficient and cost-effective operations for Pima County committees, programs, and workforce.
