Tax Sale (TS-0033 Timberline Land and Cattle Inc.) Lot 387 of Diamond Bell Ranch Tucson Unit 11

**\*Introduction/Background:**

Resolution for the sale of land conveyed to the State of Arizona under a Treasure's Deed, to James D. Dawson, Tina M. Dawson, and Jordan J. Dawson.

**\*Discussion:**

On December 16, 2019, tax parcel 301-69-3870 (the "Property") was conveyed by Treasurer's Deed to the State of Arizona due to Outstanding delinquent taxes. The Property is an approximately 1.0 acre site of vacant land located in the Diamond Bell Ranch Tucson Unit No. 11 subdivision, with an address of 16451 W. Nucla Avenue. The sale of the Property is pursuant to ARS 42-18303, to the highest bidders, which are James D. Dawson, Tina M. Dawson, and Jordan J. Dawson.

**\*Conclusion:**

The Pima County Treasurer's office will receive revenue for Property conveyed to the state for delinquent taxes, and the property will be restored to the tax roll.

**\*Recommendation:**

It is recommended that the Board of Supervisors approve the Resolution authorizing the sale of the Property to James D. Dawson, Tina M. Dawson, and Jordan J. Dawson

**\*Fiscal Impact:**

Pima County Treasurer will receive funds for property that has been conveyed to the State for delinquent taxes consisting of a sales price of \$6,100.00 plus an administrative fee to Real Property Services of \$500.00, for a total of \$6,600.00
