Re: **Vaccination of County Employees**

Attached is the latest data associated with active employees who have been vaccinated against COVID-19. In total, 4,823 have been vaccinated and verified as of October 2, 2021. This constitutes a vaccination rate of active employee of 75 percent.

The data ranks departments from least vaccinated to highest percentage vaccinated. In total, the difference between those vaccinated and active employees is 1,453 active employees who are unvaccinated or who have not filed for an I'm Vaccinated badge with Human Resources that verifies vaccination.

In addition, Human Resources has received 58 requests for accommodation; 51 for religious reasons and 7 for medical reasons.
