
Attached are 83 signatures from Pima County residents who are saying NO. Please read this cover letter and the 83 names attached into the meeting record.

Agenda Addendum Item #3 K-12 Mask Mandate & Item #4 Vaccine Mandates

Hello Board of Supervisors,

I'm the parent of two children in this county that attend school and are unmasked. My children have been unmasked since early 2021 and have not contracted Covid even when they have been in contact with children that have, even when unmasked. The majority of the cases of children that contract Covid (even unvaccinated) recover within a few days from cold-like symptoms. Each day they are finding that natural immunity is lasting longer than originally thought. Each day more children 12 years and older are being vaccinated.

I'm emailing you to let you know that my children will NEVER be masked in ANY form in order to attend school. Both of my children have medical reasons but even if they didn't I would still tell you this. A mask is a medical device and it is up to each PARENT to decide if their child needs a mask. I'll even take it a step further, you will also NEVER mandate that my children be vaccinated for Covid to attend school. I already have their exemptions on file with their school. I am their parent and what I say goes...not you.

If you somehow get this through, I WILL pull my children from school and you will lose the funding you receive from the state for them...for them that's roughly 60k. I will apply for that money myself and have a private tutor brought in to teach them at home. I will also band together with other parents and sue you. I will not stop until those of you that vote on the wrong side of this see justice - because it will be VERY personal at that point.
