Re: Pima County Adult Detention Center – Security Electronics and Mechanical Design Add Services

Ken,

We sincerely appreciate the opportunity to assist Pima County Facilities Management with the Security Electronic Systems design and construction administration services for the Pima County Adult Detention Center project. We have developed this proposal, which outlines the additional services related to the design and construction administration effort along with associated fees.

DESCRIPTION OF CHANGES

During the design of our project there have been other plans for improvements relative to the site and main facility entrance that could benefit from adjustments to our design. The site improvements include a fenced perimeter with multiple controlled gates. These gates will require control, monitoring, video surveillance, and communication to properly operate as the Users intend. The site project will not be completed until after our project, so we will expand our scope to include these control points as future integration and ensure that the systems being installed encompass these elements of security electronics.

The Lobby Entrance to the facility is also being remodeled, which may run closer to our project schedule. This remodel includes modifications to entrance doors for control, monitoring, and communications. We will expand our scope to review the remodel design in this area and include the security electronics modifications in our design as necessary.

During our design process, it was determined that the existing spaces allocated for the Uninterruptible Power Supplies (UPS) were not adequate to accommodate the size of the new units. We worked with the facility to determine appropriate locations for the new UPS. In doing so, we found that these alternate spaces are not adequately conditioned to accommodate the units. We have asked DLR to provide us with an additional services proposal to review these spaces and provide a design that will address the cooling needs.

This proposal also includes services for DLR to identify generator backed circuits to serve existing air compressor serving pneumatic locking system and their sub-contractor, Priority1 Power Services, to perform a 30-Day Power Survey. Their proposal for services is included as Attachment 3: Priority1 Proposal. The power survey is typically handled by the facility but due to the complication of the work, we have been asked to bring a sub-contractor on and provide oversight to ensure this work is carried out as our electrical engineers deem appropriate.

This proposal includes fees for the additional site gates security electronics, entrance lobby door security electronics, 30-Day power survey, and mechanical survey and design (if necessary) for the alternate UPS spaces. We will provide design and construction administration services related to this scope and have broken the additional fees out respectively.
