*Title:		
Resolution No. 2021providing for the vacation and abandonment of Twin Lakes Drive.		
*Introduction/Background:		
Numerous applications have been received for the vacation and abandonment of a portion of Twin Lakes Drive. The roadway is a public road lying within Section 9, Township 11, Range 14 G&SRM, Pima County, Arizona, as shown on attached Location Map. File #A-0052.		
*Discussion:		
The subject roadway was dedicated by the subdivision plat for Twin Lakes, Lots 1-148, recorded on May 7, 1964 in Book 17 at Page 70 In Pima County, Arizona. An analysis by the Pima County Department of Transportation has determined that proposed abandonment areas are surplus to the needs for the public roadway and recommends waiver of the application fees and property value to owners abutting the roadway that have submitted an application.		
*Conclusion:		
This abandonment request has been reviewed and approved by appropriate County staff and applicable utility companies and no property will be left without public or private legal access. County has determined that the subject roadway is not needed for public use and shall be vacated upon conveyance to the applicants.		
*Recommendation:		
Staff recommends that the Pima County Board of Supervisors approve Resolution No. 2021		
*Fiscal Impact:		
Pima County will be removed from liability and have no maintenance responsibilities toward the subject roadway.


LOCATION MAP

RESOLUTION OF THE PIMA COUNTY BOARD OF SUPERVISORS FOR THE VACATION OF PUBLIC RIGHT-OF-WAY, PLANNED DEVELOPMENT ROADWAY, AS PIMA COUNTY ROAD ABANDONMENT NO. A-0052 LOCATED WITHIN SECTION 9, TOWNSHIP 11 SOUTH, RANGE 14 EAST, G&SRM, PIMA COUNTY, ARIZONA

The Board of Supervisors of Pima County, Arizona finds:

- Numerous applications have been received by Pima County for the vacation of a portion of Twin Lakes Drive, a public roadway in Twin Lakes, Lots 1-148, planned development and subdivision recorded in Book 17, at Page 70 of Maps and Plats; said roadway being more particularly described and depicted in each attached Exhibit "A" (the "Roadway").
- 2. The Roadway was created by subdivision plat dedication and aportion has never been constructed and is not needed for public use pursuant to A.R.S. §§ 28-7202 and 28-7215(B).
- 3. The Roadway may be disposed of by vacation to adjacent property owners ("Grantees") pursuant to A.R.S. § 28-7205 and A.R.S. § 28-7215(B).

NOW, THEREFORE, BE IT RESOLVED,

The Roadway described and depicted in each <u>Exhibit "A"</u> will be disposed of by vacation by Quit Claim Deed, to Grantees, without compensation, in accordance with A.R.S. § 28-7205 and A.R.S. § 28-7215(B).

Upon recordation of the Quit Claim Deeds, the Roadway shall be deemed to be vacated and title shall vest in the Grantees.
