Introduction/Background:

Exemption applicants who have missed March 1st deadline seeking a waiver under A.R.S. 42-11153(B).

Discussion:

Approval of these waivers would allow the Assessor's Office to process exemptions for qualified property owners who have missed the March 1 deadline, but have otherwise shown that they meet necessary requirements in A.R.S. 42 Article 3.42-11101 - 42-11155.

Conclusion:

Individuals and/or non-profits who meet the requirements of A.R.S. 42 Article 3 "Exemptions" would be granted exemptions after the March 1st deadline.

Recommendation:

Approve redemption of waiver of exemption deadline as provided in A.R.S. 42-11153(B)
