Honorable Members of the Pima County Board of Supervisors:


At some point, in the recent past, a group of land speculators were formed to purchase a beautiful piece of desert landscape on Cortaro Farm Road. This group, now called Projects International, Inc., knew of the current zoning restrictions for this land, but chose to gamble that they could persuade and manipulate Pima County public officials to change these zoning restrictions, so that they could destroy this beautiful landscape, and reap a huge profit for themselves by filling it with high density housing. On September 29, 2021, they went before the Pima County Zoning and Planning Commission and sought permission to put their selfish plan into action. However, the wise Planning and Zoning Commissioners voted against their plan and DENIED approval. Undaunted by this defeat, Projects International, Inc. immediately tried to ignore the decision of the Commissioners, and the wishes of the area Homeowners, and arranged, once again, to try this time to persuade and manipulate the Pima County Board of Supervisors to approve their plan.

On November 16, 2021, an important meeting is to be held. Five members of the Pima County Board of Supervisors are tasked to uphold the decision of their fellow public servants and, once again, DENY approval of the P21SP00001 Project. But you five Board members do not have to make this decision alone. Hundreds of area homeowners have sent e-mails, letters, phone calls, and signed a Petition expressing their wishes and support to the Pima County Board of Supervisors to follow the decision of the Zoning and Planning Commission and, once again, DENY APPROVAL of this Project. The voices of the many, who care about this land and who live in this area, must be heard and followed over the pleadings of the few who do not live in this area and whose only concern is financial gain.

The homeowners in this area enjoy the natural desert beauty around their homes. Many of them bought their homes in this area for that very reason. Once it is gone it is gone forever. Also, they don't want the added congestion, noise, and traffic problems associated with more homes. New construction of homes are occurring all over Tucson and plenty of housing is available. More houses mean more water usage and Arizona is already in a water crisis situation. The school right across from the property is already near capacity and couldn't support large numbers of new students from the area. This Project doesn't benefit area residents in any way. Again, the only ones to benefit from the approval of this Project is Projects International, Inc. who reap the financial rewards. They don't live here and don't have to deal with the added problems they create. Their title, "Projects International, Inc" tends to denote that they have land projects in a lot of different areas. Perhaps it's time they take a loss on this Project they chose to gamble on, and move on to an area where the residents want more housing. There is no room for compromise here. Hundreds of area Homeowners want to keep this beautiful area just like it is. And your DENIAL can accomplish this goal.
