Honorable Members of the Pima County Board of Supervisors:

At some point, in the recent past, a group of land speculators were formed to purchase a beautiful piece of desert landscape on Cortaro Farm Road. Hundreds of area Homeowners want to keep this beautiful area just like it is. And your DENIAL can accomplish this goal.
