Project Title / Description: Intergovernmental Agreement Between the Pascua Yaqui Indian Tribe of Arizona and Pima County

Purpose: Pima County and the Pascua Yaqui Indian Tribe of Arizona have an existing IGA to coordinate the prompt processing, execution, and enforcement of state or tribal warrants, demands for extradition, and protection orders. Additionally, the IGA authorizes the appointment of a tribal prosecutor as a Special Deputy County Attorney where the State of Arizona has proper jurisdiction that occur on the Tribe's reservation, or where the offenses occur outside of the Tribe's reservation involving tribal-member perpetrators for crimes that are victimless or crimes involving victims that are not tribal members.

To facilitate the goals of criminal justice across jurisdictions, Pima County and the Pascua Yaqui Indian Tribe of Arizona seek to amend the scope of the IGA to encompass cooperation on criminal offenses involving victims that are tribal members.

Program Goals/Predicted Outcomes: Pima County and the Pascua Yaqui Indian Tribe of Arizona will work together in good faith to manage and control immediate jurisdictional questions in the furtherance of justice and provide a model for state-tribal cooperative agreements in administrating justice by consolidating key actors and centralizing decision making.





**First Amendment to the Intergovernmental Agreement Between the Pascua
Yaqui Tribe of Arizona and Pima County**

WHEREAS, Pima County, a political subdivision of the State of Arizona, on behalf of the Pima County Attorney's Office ("County"), and the Pascua Yaqui Tribe of Arizona ("Tribe"), a federally recognized Indian tribe (collectively the "Parties"), entered into an Intergovernmental Agree (IGA"), on November 15, 2022 (County Contract No. CTN-PCA-23*071), and

WHEREAS, the Parties desire to amend this IGA to further facilitate a cooperative approach to law enforcement to enhance public safety to protect all persons and property within the Tribe's reservation and the County;

NOW THEREFORE, the Parties, pursuant to the above, and in consideration of the matters and things hereinafter set forth, do mutually agree to amend the IGA as follows:

1. Section II (Scope) of the IGA is amended to read:

The Parties, through their respective law enforcement agencies, shall work together in good faith to:

- A. Provide prompt processing and removal of criminal defendants from the jurisdiction of the other Party in accordance with written demands for extradition pursuant to A.R.S. § 13-3869 (extradition of persons to and from Indian jurisdiction) and 3 PYTC §§ 2-2-1000-1090.
- B. Provide prompt assistance in the execution of arrest or search warrants upon request from the other Party, and promptly and fully enforce orders of protection duly filed with the clerk of the appropriate court pursuant to A.R.S. § 12-1702 and 4 PYTC §1-1330 and 4 PYTC §1-1335.
- C. Provide training, at their own expense, to their respective law enforcement agencies, necessary to fully comply with the terms of this IGA.

The Parties shall also work together in good faith to arrange for the appointment of a tribal prosecutor as a Special Deputy County Attorney in the Pima County Attorney's Office. This

Special Deputy County Attorney shall, at the direction and under the supervision of the Pima County Attorney, facilitate the prosecution of certain criminal offenses, for which the State of Arizona has proper jurisdiction (1) that occur on the Tribe's reservation, or (2) where the offenses occur outside of the Tribe's reservation involving tribal-member perpetrators for crimes that are victimless or crimes involving victims that are not tribal members, or where criminal offenses involving victims that are tribal members, the Tribe's government or enterprises or any subsidiaries or affiliates thereof, in Pima County Consolidated Justice Court, Pima County Superior Court, or any other court of competent jurisdiction as appropriate. While performing duties under this IGA the Special Deputy County Attorney will remain an employee of the Tribe, which will be solely responsible for payment of wages, workers' compensation benefits, if applicable, and any other fringe benefits of said employee.

The Special Deputy County Attorney shall be licensed by the State of Arizona to practice law and subject to the Arizona Rules of Professional Conduct as promulgated by the State Bar of Arizona and with any local governing agency that applies appropriate professional licensing standards and effectively ensures the competence and professional responsibility of its licensed attorneys.

2. The following provision is added to the IGA as Section XXIII. (Counterparts):

This IGA may be executed in two or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. The signature pages from one or more counterpart may be removed from such counterpart and attached to a single instrument.

IN WITNESS WHEREOF, each Party has caused this IGA Amendment to be executed by a representative of its governing body, and attested by its clerk, upon resolution of its governing body.


Intergovernmental Agreement Determination
