- December 2025 Board Action
 - Contract approved for expedited cleanup / maintenance response
- December to Date:
 - 20+ sites
 - 85.89 tons
 - Total cost to date: **\$92,652.90**
 - > Waterways / channels along the Chuck Huckelberry Loop and throughout the region in response to encampment debris
 - > Totals do not include collection / costs incurred by other Pima County land managing departments
- The Chuck Huckelberry Loop Survey
 - Launched February 26



Amazon Flats | City of Tucson / El Pueblo Development
Completed 2025

- Since 2022, over **\$20.9M** for **28** affordable housing projects
 - **1,857 units** of affordable housing for 30 years
 - > **5 projects (593 units)** award funding for sites developed / preserved by City of Tucson / El Pueblo
- **10-Year Regional Housing Strategy & Funding Plan**
 - Board Policy D 22.17 | **\$250M** over ten years
- **FY2026 \$3.5M “Keep People Housed”**
 - Home Repair / Weatherization
 - Rent, Mortgage & Utility Assistance
 - Rehousing for Homeless Individuals / Families
 - **649 Total Households Served to Date**
- **Regional Shelter Dashboard**
 - **County IT / GIS**
 - partnership with **Tucson Pima Collaboration to end Homelessness (TPCH) & Southwest Institute for Research on Women (SIROW)**
