Strengthen Public Health & Treatment Access

Health | Detainee and Crisis Systems

- Ongoing countywide overdose prevention programming
- Summer 2026 heat planning & cooling center coordination underway
- Exploring opportunities within current and / or future legislative session for expanded coverage for people in early and long-term recovery.



Expand Treatment & Diversion Programs

Health | Justice Services | County Attorney's Office

- Sobering Alternative for Recovery (SAFR) Center
 - Launched January 1, 2026
 - Voluntary low-barrier settings
 - Ongoing County & City coordination implementation and utilization
- Expanded operations at the Transition Center
 - Justice Services planning to begin recruitment
- Discussions on enhancements to diversion programs ongoing

- Continued dialogue on improved access / utilization of shelter




Support Impacted Neighborhoods & Small Businesses

A Framework for Safety, Recovery, & Treatment

The One Pima Initiative is Pima County's two-year coordinated plan to strengthen public safety, expand treatment and recovery services, support housing stability, protect public health, and improve the condition of the Chuck Huckelberry Loop and County-managed public spaces.

Priority Areas

- 1: Prioritize Loop Cleanup & Safety**
 - Restore and maintain clean, safe Loop pathways, parks, and washes.
 - Develop a safety plan for additional Loop lighting, signage, mile markers, and a new Wellness App for reporting and user safety.
- 2: Strengthen Public Health & Treatment Access**
 - Support and maintain Countywide overdose prevention, youth education, and behavioral health programs, run by a wide variety of community partners.
 - Ensure people in custody receive treatment and continued care when released.
 - Sustain cooling centers during extreme heat.
 - Advocate at the State for expanded coverage for people in early and long-term recovery.
- 3: Expand Treatment & Diversion Programs**
 - Increase capacity at the Transition Center to operate seven days a week.
 - Strengthen diversion programs that move people into treatment instead of jail.
 - Improve reentry support for low-risk justice-involved individuals.
 - Pilot the Sobering Alternative for Recovery (SARF) Center through Opioid settlement dollars.
- 4: Stabilize Housing & Prevent Homelessness**
 - Continue significant County investments in housing, including affordable construction, rental assistance, supportive housing, and weatherization.
 - Expand partnerships for transitional and supportive housing.
 - Develop a regional real-time system showing available shelter and beds.
 - Address shelter barriers: pets, storage, and bathroom & shower facilities.
- 5: Support Impacted Neighborhoods & Small Businesses**
 - Launch the Silverlake-Mission Reinvestment Zone planning study to improve roads, parks, and neighborhood infrastructure.
 - Study a Small Business Safety & Recovery Pilot to help local businesses offset safety-related expenses.

LOOP CLEANUP AND PUBLIC SAFETY

Goal
Make the Loop cleaner, safer, and easier to use for everyone.

Why it matters
The Loop covers more than 138 miles and connect neighborhoods across the region. Clean, safe public health, and protect shared public spaces.

What's happening now

- More frequent cleanup of paths, parks, and washes
- Removal of debris and safety hazards
- Planning for better lighting, signage, and mile markers

What's coming next


- New lighting and safety signs in priority areas
- A Wellness App to report issues and access safety information
- Expanded cleanup coverage across the park system

Goal
Protect and strengthen public health and ensure people across the region can need them.

Why it matters
Substance use, behavioral health challenges, and extreme weather events impact services save lives, reduce strain on emergency systems, and help people stay stable.

What's happening now

- Supporting countywide overdose prevention and behavioral health programs
- Funding youth education and prevention efforts through community partners
- Providing treatment for people in custody and coordinating care upon release
- Operating cooling centers during periods of extreme heat

What's coming next


- Expanded continuity of care for people transitioning out of custody
- Continued investment in prevention and recovery programs
- Advocacy at the State level for broader coverage for people in early and long-term recovery

Current status

- Overdose prevention & behavioral health programs: **Ongoing**
- Cooling centers: **Seasonal / Active during extreme heat**
- State advocacy for recovery coverage: **Ongoing**

Reduce reliance on jail by expanding treatment options and diversion programs that connect people to care and long-term stability.

Why it matters
Substance use, behavioral health challenges, and extreme weather events impact services save lives, reduce strain on emergency systems, and help people stay stable.

What's happening now

- Expanding services at the [Pima County Transition Center](#)
- Strengthening diversion programs that redirect people into treatment
- Improving reentry support for low-risk justice-involved individuals

What's coming next

- Transition Center operations expanded to seven days a week
- Pilot launch of the [Sobering Alternative for Recovery \(SARF\) Center \(PDF\)](#)
- Continued [investment in treatment-based alternatives using opioid settlement dollars](#)
