**Purpose:** To exchange water use data to support Pima County's sewerage user fee system and to compensate the City of Tucson for providing the data and billing County customers for sewerage system user fees.

CT\_1800000000000000196 Amendment 02 refers to the expense portion of the agreement between Pima County and City of Tucson whereby City of Tucson provides sewer billing and collection services for a fixed fee of \$1.58 per account for the term of the amendment; CT2600000055 refers to the revenue portion of the agreement between Pima County and City of Tucson whereby collected sewer collection fee payments are remit to Pima County on a monthly basis.



Second Amendment  
to the  
Intergovernmental Agreement  
between  
Pima County and the City of Tucson  
for  
Wastewater Billing Services

Whereas, the City of Tucson, a municipal corporation ("City"), and Pima County, a body politic and corporate of the State of Arizona ("County") (collectively the "Parties"), entered into an Intergovernmental Agreement ("IGA"), effective January 1, 2018 (City Contract No. 18549; County Contract No. CT-WW-1800000000000000196), for the provision by City of sewer billing services to County for a five-year term; and

Whereas, the Parties amended the IGA to extend the term for a period of thirty-six (36) months until December 31, 2025, and to retain the billing rate at \$1.43 per account; and

Whereas, the Parties desire to extend the IGA term for twelve (12) months until December 31, 2026; and

Whereas, the IGA billing fee will be set at \$1.58 per account for the term of the IGA extension, and,

Whereas the parties desire to authorize mutual Director approval for one additional twelve (12) month extension, to December 31, 2026, and to set the billing rate at \$1.58 per account.

Now, therefore, City and County, pursuant to the above, and in consideration of the matters and things hereinafter set forth, do mutually agree as follows:

1. Paragraph D, Term is amended to read:

This IGA shall be effective on January 1, 2018, for a five (5) year period, and extended beyond the First Amendment termination date of December 31, 2025, for another twelve (12) months until December 31, 2026. County and City retain the option to exercise one (1) additional extension option of 12 months. Either party may terminate this agreement with not less than six (6) months' written notice.

2. All other terms and conditions of the IGA shall remain unchanged except Agreement may be executed in one or more counterparts, each of which will constitute an original and all of which shall be one and the same Agreement.

In witness whereof, County has caused the Intergovernmental Agreement to be executed by the Chair of its Board of Supervisors and attested to by the Clerk of the Board, and the City of Tucson has caused this Intergovernmental Agreement to be executed by the Mayor upon resolution of the Mayor and Council and attested to by the City Clerk:

RESOLUTION NO. 24109

RELATING TO WATER; AUTHORIZING AND APPROVING A SECOND AMENDMENT TO THE INTERGOVERNMENTAL AGREEMENT (IGA) WITH PIMA COUNTY FOR WASTEWATER BILLING SERVICES; EXTENDING THE TERM OF THE IGA FOR ANOTHER TWELVE (12) MONTHS UNTIL DECEMBER 31, 2026; AND DECLARING AN EMERGENCY.

WHEREAS, Tucson Water has provided billing services to the Pima County Regional Wastewater Reclamation Department (RWRD) since 1979, when the City's wastewater system was transferred to Pima County; and

WHEREAS, throughout this period, the City and County have negotiated Intergovernmental Agreements for the associated services and fees; and

WHEREAS, on January 1, 2018, by Resolution No. 22842, Mayor and Council approved a renewed five-year IGA, which expired on December 31, 2022; and

WHEREAS, on November 11, 2022, by Resolution No. 23543, Mayor and Council approved a first amendment to extend the Term of the IGA for an additional three years until December 31, 2025; and

WHEREAS, approval of the current second amendment to the IGA will result in continued partnership with Pima County RWRD for billing services under the same scope of work, with an updated fee schedule for an additional twelve (12) months until December 31, 2026, with an option for an additional one-year extension until December 31, 2027:

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND COUNCIL OF THE CITY OF TUCSON, ARIZONA, AS FOLLOWS:


SECTION 1. The Second Amendment to the IGA between Pima County and the City of Tucson for Wastewater Billing Services extending the term of the IGA for an addition twelve (12) months until December 31, 2026, attached as Exhibit 1, is approved.

SECTION 2. The Mayor is authorized and directed to execute said IGA for and on behalf of the City of Tucson and the City Clerk is authorized and directed to attest to the same.

SECTION 3. The various City officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this Resolution.

SECTION 4. WHEREAS, it is necessary for the preservation of the peace, health and safety of the City of Tucson that this Resolution become immediately effective, an emergency is hereby declared to exist, and this Resolution shall be effective immediately upon its passage and adoption.


