**CONTRACT AMENDMENT # 10**

The parties agree to amend the above-referenced contract as follows:

**1. Background and Purpose.**

1.1. Background. On August 25, 2020, County and Contractor entered into the above referenced agreement to provide Representation of Pima County in *Taylor v. Pima County, et al.*

1.2. Purpose. County requires continuing services and additional time and funds are needed to complete those services.

**2. Term.** The County is exercising the sixth extension option to renew the contract for one additional year commencing on August 24, 2026 and terminating on August 23, 2027. If the commencement date is before the Effective Date of this amendment, the parties will, for all purposes, deem the amendment to have been in effect as of the commencement date.

**3. Maximum Payment Amount.** The maximum amount the County will spend under this Contract, as set forth in Section 5.2, is increased by \$90,000.00. County's total payments to Contractor under this contract, including any sales taxes, will not exceed \$1,035,000.00.

All other provisions of the Contract not specifically changed by this Amendment remain in effect and are binding upon the parties.
