CONTRACT AMENDMENT

The parties agree to amend the above-referenced contract as follows:

1. **Background and Purpose.**
 - 1.1. **Background.** On February 07, 2023, County and Contractor entered into the above referenced agreement to provide Dispatch Services.
 - 1.2. **Purpose.** Contractor requires additional services through Pima County Sheriff's Department to provide dispatch services and the management of dispatch logs and warrants records to Saguro National Park. This Amendment is to extend the term and increase the amount for the additional services.
2. **Term.** The County is exercising the third extension option to renew the contract for 12 additional months commencing on July 1, 2026 and terminating on June 30, 2027.
3. **Maximum Payment Amount.** The maximum amount the Contractor will spend under this Contract, is increased by \$26,385.00. The Contractor's total payments to County under this contract, will not exceed \$103,750.00.
