This amendment extends the term of the contract to 06/15/26 due to a continuing need for On-Call Design Engineering Services at the Eric Marcus Municipal Airport. The term extension allows for completion of a new solicitation process which was delayed due to Federal changes to the Disadvantaged Business Enterprise (DBE) program requirements. Insert additional Procurement Method info, if applicable: Pursuant to Solicitation for Qualifications No. SFQ-PO-2100004, on 04/12/21, the Procurement Director awarded a Master Agreement for these services in an amount of \$250,000.00 for an Agreement term of 04/16/21 to 04/15/22.

Amendment No. 1 was approved by the Procurement Director, on 4/11/22, to add the full annual award amount of \$250,000.00 for a cumulative not-to-exceed amount of \$500,000.00 and extend the term of the agreement to 04/15/23 due to the ongoing need for these services.

Amendment No. 2 was approved by the Procurement Director, on 03/21/23, to add the full annual award amount of \$250,000.00 for a cumulative not-to-exceed amount of \$750,000.00, extend the term of the agreement to 04/15/24 due to the ongoing need for these services, and add the Forced Labor of Ethnic Uyghurs clause to the contract.

Amendment No. 3 was approved by the Procurement Director, on 04/01/24, to add the full annual award amount of \$250,000.00 for a cumulative not-to-exceed amount of \$1,000,000.00 and extend the term of the agreement to 04/15/25 due to the continuing need for these services.

Amendment No. 4 was approved by the Procurement Director, on 04/15/25, to change the contract number to SC2400001195 (formerly MA-PO-21-156), change the contract verbiage from Master Agreement to Supplier Contract, add a partial annual award amount of \$200,000.00 for a cumulative not-to-exceed amount of \$1,200,000.00, extend the term of the agreement to 04/15/26 due to the continuing need for these services, and add the Heat Injury and Illness Prevention and Safety Plan clause to the contract.

1. CHANGE: **ARTICLE 1 – TERM AND EXTENSION/RENEWAL/CHANGES**, 1st paragraph as follows:

TO: “This Agreement, ... terminates on June 15, 2026, unless sooner terminated or further extended pursuant to the provisions of this Agreement...”
